## About the Euro-Mediterranean University Institute (EMUI)

The **Euro-Mediterranean University Institute (EMUI)** was founded in collaboration with the Complutense University of Madrid host to our Spain Campus, and an EU, Maghreb and Middle East University Consortium. Officially launched in Malta on **October 16th 2007**, the events were hosted at the Mediterranean Conference Centre (Valletta), with institutional support from the Government of the Republic and the Embassy of Spain.

Recent developments in the Maltese Education Act now enable the EMUI to apply for the Tuition Centre status with views to establish a second campus for its academic provision in line with our pan-European foundational goal. Former Spanish Minister for Universities and Chair in Sociology, Dr Luis González-Seara holds the maximum institutional representation.

The EMUI designs and delivers its academic and research projects in partnership with Universities of the Consortium, which undertake teaching commitments in the EMUI academic provision at their own expense, in line with the not-for-profit scope and applicable bilateral agreements. This is reflected within the Academic & Research Council and the Advisory Board as appropriate. Nonetheless, consultation may be undertaken with suitable Maghreb and Middle East institutions external to the Consortium to ensure optimal quality standards.

## The Euro-Mediterranean University Institute in Madrid

The **Euro-Mediterranean University Institute (EMUI)** arises in Spain as a Research University Institute of the Complutense University of Madrid (UCM). In cooperation with the homologue institutions in Malta and Fes (Morocco), the creation of the EMUI\_UCM implies the consolidation of the Euro-Mediterranean Southern University. The Complutense Institute – EMUI was approved by the UCM Government Council on **December the 16th, 2009**.

The Autonomous Community of Madrid (CAM) has a broad scientific and research variety of programs with high quality, which are developed through the different higher education centers, attached in virtue of the corresponding State competences transferred. These circumstances and others such as geostrategic, political, social and economical considerations make it appropriate, Madrid to arise as a reference for excellence programs, multidisciplinary and convergent, covering those issues dealing with the building of the European model and the policies aimed at the guaranteeing of the success of the project. The offer of the CAM would be notably reinforced.

The projection and international cooperation at a scientific-cultural and academic-research level of the EMUI would reinforce the complementary projection and international cooperation at a political-institutional, socio-economical and business level. We would like to highlight that the EMUI becomes the first Spanish University Institution with specific competences, which necessarily have interdisciplinary character, referred to its purpose and goals.

## Institutional Relations

Worth acknowledging are the contributions by Universities of the Consortium, the EMUI Executive Board and the Cabinet & Coordination team. Nonetheless, as per agreed at the Second Academic and Research Council Meeting, held on May 31<sup>st</sup> 2008, a more systematic approach is currently underway to render longer term commitments sustainable through the enlargement of our Advisory Board and Academic & Research Council.

## EN | Foundational Goals

- I. To develop teaching and research quality programs focused on the European Union and its projection upon the Mediterranean Area.
- II. To form professionals in every area of punctual interest for European and Euro-Mediterranean institutions. These professionals will meet the standards of quality set by social, political and economic sectors involved.
- III. To offer programs of continuous education for updating knowledge and basic skills of the above referred professionals.
- IV. To foster the spreading of results through specialized media. There will be also a presence in general media, according to the interests of their users.
- V. To draw up proposals of continuous education through courses, seminars or conferences that will be available to any citizen, with the purpose of guaranteeing accurate and critical information on the ongoing development of the EU, particularly in relation to Mediterranean issues.
- VI. To advise public and private institutions on the aforementioned issues. Consultant panels will be set up to pursue this goal.
- VII. To set up institutional teaching and research networks, with or without extra-communitarian partners, in order to improve the spreading of results. It will be also be a target to establish partnerships with other institutions in order to create local, regional or communitarian programs to be developed at the affected geopolitical areas.

## DE | Foundational Ziele

- I. Qualitative Lehr- und Forschungsprogramme mit dem Focus auf die Europäische Union und ihre Projektion in die mediterrane Region zu entwickeln.
- II. Experten in den spezifischen Interessenbereichen europäischer und euromediterranen Institutionen auszubilden. Diese Experten werden auf einem hohen Niveau den sozialen, politischen und ökonomischen Sektor miteinbeziehen.
- III. Angebote einer weiterführenden Ausbildung zu entwickeln, die das Fachwissen und die Grundkenntnisse der oben genannten Experten auf den neuesten Stand bringen.
- IV. Die Verbreitung der Resultate durch fachkundige/ spezielle Medien zu fördern. Es wird außerdem eine Präsenz von allgemeinen Medien vorhanden sein, die den Interessen der Nutzer entsprechen.
- V. Vorschläge einer weiterführenden Bildung auszuarbeiten, Kurse, Seminare oder Konferenzen, die jedem Bürger zur Verfügung stehen mit dem Ziel akkurate und kritische Informationen zu den aktuellen Entwicklungen in der EU, insbesondere in Bezug auf die Mediterranen Angelegenheiten, zu garantieren.
- VI. Öffentliche und private Institutionen in den vorhergenannten Angelegenheiten zu beraten. ZU diesem Zweck sollten beratende Gremien gegründet werden.
- VII. Ein institutionelles Lehr- und Forschungsnetzwerk aufzubauen, mit oder ohne außereuropäischen Partnern, um die Ausbreitung von Ergebnissen zu verbessern. Außerdem ist es ein Ziel Partnerschaften mit weiteren Institutionen zu etablieren, um lokale, regionale oder europäische Programme einzurichten, die aus den betroffenen geopolitischen Bereichen zu entwickeln sind.

## ES | Objetivos Fundacionales

- I. Desarrollar Programas Docentes y de Investigación de calidad sobre la Unión Europea y su proyección en el Área del Mediterráneo.
- II. Formar, en consecuencia, a profesionales en cada uno de los campos de interés puntual para las instituciones europeas y euro-mediterráneas al nivel de exigencia de los sectores sociales, políticos y económicos afectados.
- III. Diseñar ofertas de formación continua que actualicen los conocimientos y recursos básicos de tales profesionales.
- IV. Fomentar la difusión de los resultados a través de medios especializados, sin perjuicio de una recomendable información en los medios convencionales, a tenor del interés o expectativa de sus usuarios.

- V. A través de cursos, seminarios o conferencias, diseñar asimismo ofertas de formación continua, a disposición de cualquier ciudadano que lo demande, que garanticen una información veraz y crítica sobre la actualidad en el desarrollo y proceso de la UE con especial incidencia en los intereses del Mediterráneo.
- VI. Asesorar a través de gabinetes especializados a instituciones públicas o privadas en materias de su competencia de acuerdo con las exigencias del momento.
- VII. Establecer, por último, redes institucionales de investigación y docencia, comunitarias y extracomunitarias, no sólo para una más eficaz circulación de resultados: en colaboración con los órganos competentes y en uso de los recursos que procedan, es objetivo del EMUI diseñar conjuntamente programas locales, regionales o comunitarios a desarrollar directamente en las áreas geopolíticas más afectadas.

## PROFESSORS, LECTURERS AND RESEARCHERS

The communitarian institutions, the conferences of rectors and university consortia, as well as the experts informs alert to the urgent need to design quality programmes for university professors training, in order to fill the sort-term scarcity of the EU universities and research centres that predictions indicate. The EMUI, giving priority to this objective, offers the following:

### Researcher Programme | Research Body

The **Research Teaching Body** consists of a) **EMUI Researchers** (Senior and Junior) and b) **Associated Researchers** (Senior and Junior). The EMUI selects its Researchers among the Associated Researchers, according to proved quality and excellence. If the candidate obtains an **Externally Funded Fellowship** can also accede to the position of EMUI Researcher. It is possible to opt for a post of Associated Researcher in anytime of year. Associated Researchers maintain their institutional links with the university or centre of origin.

Junior researchers (PhD candidates) will make their practice as Professors under tutelage in the First Cycle Degree (Diploma). Senior researchers (PhD) will practice as Professor-Researchers under tutelage in the First Cycle Degree (Diploma) and in the Second Cycle Degree (Masters).

### Lecturers | Lecturer Body

Invited Professors of outstanding intellectual, academic, political or business career who assume sporadic teaching responsibility in each cycle. The EMUI, according to its budget capacity, will call for selection procedures to fill the positions of Lecturers.

### Professors | Professor Body

The Universities of the Consortium assume the academic, teaching and research responsibility through their Professors of the programmes of Second (Masters) and Third Cycle (Advanced Diploma and Doctorate). The EMUI, according to its budget capacity, will progressively announce selection procedures to fill the positions of Professor-Researchers.

Doctor in Political Sciences and Administration, Professor of International Relations at Universidad Complutense de Madrid and the Centre of Excellence in European Studies Jean Monnet (UCM), Dean of the College of Political Science and Sociology (UCM), President of the Spanish Association of Professors of International Relations and Law.

### **José Barata-Moura**

Former Rector of the Universidade de Lisboa. Chair in Philosophy, author of extensive works in Philosophy and youth literature and former member of European Parliament.

### **Stefano Bartolini**

Director of the Robert Schuman Centre for Advanced Studies, European University Institute, he has been awarded the APSA prize for best book on European Politics (2002), the Gregory Luebbert APSA Prize in Comparative Politics (2001), and the UNESCO Stein Rokkan prize in Social Sciences (1990). His present academic interests are the relationships between the process of European integration and the key features of the European nation-state experience. His research interests have focused on Western European political development, comparative methodology, political institutions and European integration.

### **Gianfranco Bettin**

Lecturer in Social System Comparison and Sociological Theory, he currently coordinates the PhD in Sociology and manages the Interuniversity Centre of Political Sociology (CIUSPO).

### **Josep Borrell**

Doctor in Economics, senior lecturer at the UCM, he is also a former President of the European Parliament, former State Secretary of Finance (Spain), and former Minister for Public Works, Transport and Environment (Spain). Currently is Chairman of the European Parliament Committee on Development and also chairs the Global Progressive Forum, a think tank for a reform of globalisation based on the universal values of justice, peace, security, solidarity, freedom, democracy, and equality.

### **Máximo Cacciari**

Doctor of Philosophy, Professor of Statistics at Università Ca' Foscari Venezia, former member of the Italian and European Parliaments, former Mayor of Venice, Co- Founder and Co- Director of different journals with a notable political and cultural impact such as *Angelus novus*, *Contropiano*, *Laboratorio politico*, *Il centauro* and *Paradosso*.

### **António Câmara**

Professor at Universidade Nova de Lisboa and Visiting Lecturer at both Cornell University (1988-89) and MIT (1998-99). He was a Senior Consultant to the Expo98 project and Senior Advisor to the National Geographical Information System. He has been YDreams CEO since the company was founded in June 2000.

Professor of Sociology, Department of Sociology II (Human Ecology and Population), School of Political Sciences and Sociology, Complutense University of Madrid (1975- ). Member, Advisory Council of the Center for Sociological Research (CIS, 1999- ), Permanent Observatory for Immigration (2001- ), Scientific Committee of the Royal Institute Elcano (2002-), Scientific Committee of the Foundation for Fighting Drug Addiction (2001- ), among others.

## Filipe Duarte Santos

Chair in Physics at Universidade de Lisboa, visiting lecturer at several US and European universities. Since 1998, member of the Conselho Nacional do Ambiente e do Desenvolvimento Sustentável and of the Academia das Ciências de Lisboa. He is also member of the Comissão Nacional para as Alterações Climáticas and coordinates several national and international projects in the field of environment and climate change. He is currently coordinating researcher of Project SIAM – “*Climate Change in Portugal. Scenarios, Impacts and Adaptation Measures*”.

## José María Gil-Robles

Professor in Law and Director of the UCM Centre of Excellence Jean Monnet in European Studies, former Jean Monnet Chair, Vice-President and President of both the European Parliament and the Parliament's Bureau, Chairman of the EU Committee on Institutional Affairs, he has been awarded, among many other distinctions, the EU Parliament Gold Medal (2000), the *Légion d'Honneur* and is Doctor *Honoris Causa* by both the University of Sofia and the Moscow International Relations State Institute. Former President of the European Movement International and current Honorary President, he is also President of the Jean Monnet Foundation for Europe.

## Luis González-Seara

Doctor in Political Sciences, Chair in Sociological Theory and Sociology of Culture (UCM), former Minister for Universities and Research (Spain), member of the Spanish Royal Academy for Moral and Political Sciences, panel member of the Príncipe de Asturias Awards. Former Director of the Public Opinion Institute, Secretary of the Institute in Political Studies as well as Director of the Journal of Social Studies (RES) and CEO of EDIOBSER. He has also published extensively, *El poder y la palabra* being awarded the Spanish National Prize in Essay (1995).

## Massimiliano Guderzo

Professor of History of International Relations at the Faculty of Political Science “Cesare Alfieri”, University of Florence (Department of Studies on the State). He held the Jean Monnet Chair of the History and Politics of European Integration at the Faculty of Political Science, University of Urbino “Carlo Bo”, 2003-2006. Research coordinator of the Machiavelli Center for Cold War Studies (CIMA), he has published essays and books on British decolonisation in Africa, Spain's neutrality in World War Two, and Euro-American relations in the Sixties.

Chair in Sociology at UCM, President of Spanish Federation of Sociology, founder and former Director of Real Instituto Elcano; former State Secretary for Universities and Director of the Instituto Ortega y Gasset. ## *EuroMed: Information and Knowledge Society*

Modern societies are shored up by fundamental principles that legitimate every system claiming the appellative of democratic, and pursue to set the conditions for the instauration and stability of a welfare society. These aims are not possible without the referent of the “knowledge society”, which is expected to count with agents of the proper or generated resources. This management must not only meet the profile of the users, but also be assisted by educational policies, which disseminate the resources and promote their rational administration. A political programme of this nature is, at the same time, impossible without recurrent academic-research programmes.

The political, social and cultural space that is described is now understood as “information society”, and it is legitimated by invoking and respecting the above mentioned fundamental principles, among which it is suitable to underline the principle of solidarity. Since the priority purpose of the University, in its condition of a public service, is to echo the demands of the society, we must design programmes of rational exploitation of the resources. This is the double aim of this Master: not only to get students into the considered frame of mind, but also to suggest to them credible ways of usage, to familiarize them with the nowadays inevitable CITs and their utility.

The main goal of the Human & Social Sciences has always been to develop the knowledge and, eventually, to criticize the social and cultural environment in which they co-exist. This Master aims at rebuilding the legacy of the critical thinking (like the School of Frankfurt did in Europe and America after the two World Wars), referring this time to the characteristic realities of the current political organizations and cultural production in Europe. In both fields a problem arises on a common base. The European political organization, which is determined by the gradual convergence of its economic and social structures, has not established yet the identity signs that could make it as a real unified community. Given the fact that those identity signs cannot come from History (dominated, in the case of Europe, more by the conflicts among its members rather than by efforts of a peaceful integration), the source from which they can be obtained should be found at the heritage of its common culture.

## Fellowship Awarding Programme

### Junior Fellowships | Pre-doctoral

These Fellowships are open to candidates who have recently received their degree in Economics, Social and Political Science, Law or History, and wish to undertake doctoral studies.

### Senior Fellowships | Post-doctoral

These Fellowships are intended for recent PhD holders intending an academic career and willing want to develop their teaching and professional skills.

### Visiting Researchers and Lecturers

The EMUI may host visiting researchers under the terms and conditions of the awarded fellowships or through open calls for expressions of interest. During this period, visiting researchers will be considered EMUI researchers under the applicable rights and duties.

Every research project endorsed by the EMUI has to comply with at least one of the above-mentioned focuses. All the projects or programs of investigation, whether individual or in team, which are realized with the aval of EMUI, of the Consortium or of any of the corresponding institutions, have to pursue inherent objectives to any of the cited focuses.

### THEORIA Research Team (Critical Project in Social Sciences) | In Partnership

This research team was founded in 1988 under the name *“Europe, fin-de-siècle: Thought and Culture – Critical Project in Social Sciences”*. It is nowadays a stable and solid group (Ref. UCM 940052), and is registered in the Madrid Council for Education Directory of Research Teams (Ref. CAM 1391).

38 researchers involved with academic and research institutions in Spain and other EU countries which, during the 2005-2010 period, led to the following productivity: 124 research projects, 46 PhD. thesis; 52 Diplomas in Advanced Studies (DEA); 129 books, 209 book chapters, 295 articles.

The National Agency for Research Evaluation (Agencia Nacional de Evaluación y Prospectiva, ANEP) rated the group with a score of 63 points in a 0-70 scale. (Madrid, October.2005).

### Observatory “Euro-Med: Social Technology and Digital Citizenship”

The Euro-Mediterranean University Institute of Malta, in cooperation with the Complutense University of Madrid and under the patronage of the Anna Lindh Euro-Mediterranean Foundation, sets up the Project “Euro-Med: Social Technology and Digital Citizenship”, a digital monitoring observatory available for public and private institutions interested in the area. The University Department emerges with a triple goal: promoting the social ownership of the technology in order to contribute to the eradication of the gap in the Mediterranean area and to foster the development of a digital citizenship within the framework of the construction of the concept of Europe. This initiative complements the theoretical-practical training of those attending the Master “Information and Knowledge Society”, an academic program offered by the institutions mentioned above, which is an equally valid complementary training for professionals coming from adjacent areas.



The observatory aims at analyzing different initiatives focused on studying the concept of digital citizenship in order to build a Euro-Mediterranean common space, going further euro centrism temptations. This concept is an essential issue to integrate a community in which the digital gap finds itself at the same time with other cultural, racial, economic and territorial long standing gaps, which undermine the attempts to carry out a deep modernization of the idea of Europe and a cultural and political harmonization between the borders of the Mediterranean. This specific Euro-Mediterranean citizenship is based on the social ownership of the technology, and the consequent impact on democracy, the Human Rights fourth generation, the digital inclusive policies and the electronic governance development.

Based on descriptors such as "Citizenship and new technologies", "Citizenship and information", "Digital monitoring" the Observatory, on a specific need and descriptor ("Information Society and Globalization Cosmopolitan") is divided into the following sub-departments: 1 "Media Lab", 2 "Digital Gap", 3 "Digital Diaspora", 4 "Knowledge and Free Software" and 5 "Digital Citizenship and Digital Gap"

Given the fact that this Department operates inside the structure of the Euro-Mediterranean University Institute, all the work and research will be mainly focused on the Mediterranean area. To this end, we pretend to cover the following activities:

1. A Media Lab dealing with the research on social networks and production of free knowledge.
2. A specific research area about the digital gap, in order to generate useful indicators showing and comparing the current situation of our focus area with other areas in the world.
3. A research area dealing with the "digital Diaspora", having in account that this concept implies the use of new technologies such as mobiles, laptops and different communication systems that allow social cohesion among the migrants communities.
4. A software and free knowledge Observatory focused on the Mediterranean area, which will be in charged on producing reports about the developments and implementation of the new technologies in the region, as well as the recommendations on these issues, especially those concerning the integration of these technologies in the public administration and the e-governance.
5. An advising department dealing with the digital citizenship, as a tool to fight against the digital gap, to foment the cohesion among the different communities that live in the area and providing their own technology to the developing countries in the area.

**Goals.-** As we have indicated the specific objectives are: 1) forming and informing the public and governments in the area, 2) establishing a stable track digital observatory serving citizens and institutions, 3) making a new generation of academics lead the project and giving them the opportunity, 4) achieving greater involvement of politicians and businessmen in the proposed objectives, 5) and implementing the mechanisms for similar programs recommended by the European Commission.

The current edition, with 432 co-authors and 983 entries, reviews the first and second editions (Anthropos publishers, 1988 and 1991), and involves significant updating of circa 50 % of the entries. On average there were 84.463 hits per month in 2006, mostly from the United States (32,13 %), Spain (18,77 %) and Mexico (14,56 %). 92 European and 29 non-European institutions are represented in this dictionary.

### Malta & Fes Campus (provisional premises)

The creation of the **Euro-Mediterranean University Institute\_UCM** has implied the legitimating and reinforcement of the institutional network, which will be the support of the expected creation of the Southern-Euro-Mediterranean University by the European Commission. According to the agenda of the **2<sup>nd</sup> Euro-Mediterranean Ministerial Conference on Higher Education** (scheduled for April the 25<sup>th</sup> and 26<sup>th</sup>, and then postponed for October 2010 due to aerial navigation issues), the EMUI will have its headquarters in Fès, Madrid and Malta.

Along that same line, the Direction of the EMUI keeps fluent relations with the Direction of the *Centre Marocain Interdisciplinaire des Études Stratégiques et Internationales* (CMIESI) and the Rector of the Université Sidi Mohamed Ben Abdellah, which will become the future headquarters of the EMUI in Fès (Morocco).
